The GCCC Member e-Decal may not be altered in any form! No elements may be added to the logo or e-Decal. The logo or e-Decal may not be placed in a box or other shape. The words in the logo cannot be enlarged or reduced. It must stay in specified proportions. The font of the words or the color cannot be changed.

**Placement and Size**

The GCCC Member e-Decal may be used on member websites or may be continued in electronic correspondence (such as e-mails to customers). If used on member website, the logo must link to the GCCC website homepage.

**The proportions of the e-Decal may not be altered.**

As a condition of your use of the e-Decal, Member warrants to the Greater Clover Chamber of Commerce that Member will not use the e-Decal for any purpose that is unlawful or prohibited by these terms, conditions, and notices. Further, Member agrees to delete the GCCC Member e-Decal immediately from their website and/or e-mail messages in the event the Greater Clover Chamber of Commerce requests member to do so or if the member is no longer in good standing.
